The Iligan City Government Bids and Awards Committee (BAC), through 20% Development Fund 2022, intend to apply the sum of P 35,495,242.32 being the Approved Budget for the Contract (ABC) to payments under the Contract for REHABILITATION OF BRIDGE @ SITIO MERILA, BRGY. UBALDO LAYA, ILIGAN CITY with Project No. CB(B)-23-132 (CEO-INFRA). Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino Citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
