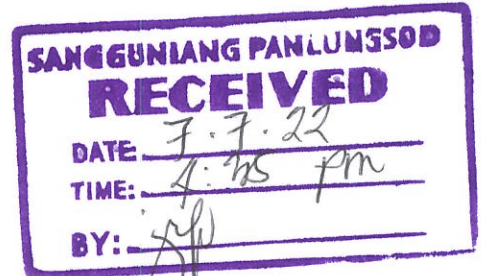

**RESOLUTION NO. 22-390**

**CITY ORDINANCE NO. 22-7182**

**AN ORDINANCE AUTHORIZING CITY VICE MAYOR MARIANITO D. ALEMANIA, TO SIGN CHECKS, VOUCHERS, PAYROLLS, AND OTHER NEGOTIABLE INSTRUMENTS, AMONG OTHERS FOR THE SANGGUNIANG PANLUNGSOD, AND TO FURNISH COPY OF THE SPECIMEN OF HIS SIGNATURE TO ALL DEPOSITORY BANKS WHERE THERE ARE DEPOSITS OF THE CITY GOVERNMENT, AS A MEANS OF DISBURSING PUBLIC FUNDS FOR THE SANGGUNIANG PANLUNGSOD**

Be it ordained by the Sangguniang Panlungsod of Iligan in its session assembled, that:

**SECTION 1.** – City Vice Mayor Marianito D. Alemania is **AUTHORIZED**, as he is hereby **AUTHORIZED** to sign checks, vouchers, and payrolls among others for the Sangguniang Panlungsod.

**SECTION 2.** – City Vice Mayor Marianito D. Alemania is **AUTHORIZED**, as he is hereby **AUTHORIZED** to furnish copy of the specimen of his signature to all depository banks where there are deposits of the Iligan City Government, as a means of disbursing public funds for the Sangguniang Panlungsod, which includes accomplishment of the required forms to realize the foregoing authority.

**SECTION 3. Effectivity** – This Ordinance shall take effect upon its approval.




