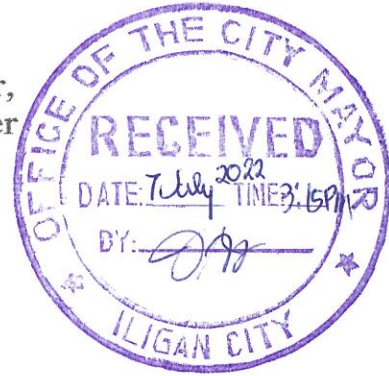

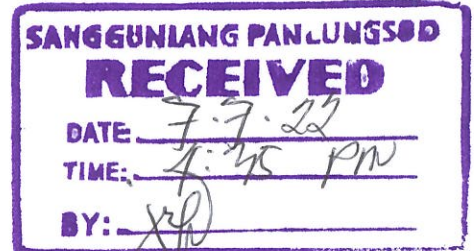

**RESOLUTION NO. 22-388**

**WHEREAS**, presented to the body for deliberation was a letter dated July 4, 2022 from City Mayor Frederick W. Siao, requesting among others for the passage of a resolution authorizing the City Mayor to sign checks, vouchers and other financial documents, for and in behalf of the City Government of Iligan;

**WHEREAS**, as Mayor of Iligan City, Mayor Siao has to perform the powers, duties and functions stipulated under Section 455 (b) (1) (vi) (*Chief Executive; Powers, Duties and Compensation*), of the Local Government Code which states:

(b) *For efficient, effective and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of this Code, the city mayor shall:*

(1) *Exercise general supervision and control over all programs, projects, services, and activities of the city government. and in this connection, shall:*

(vi) *Represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance;*

**WHEREAS**, in order to effectively performed its mandated functions to provide basic services to its constituents, a local government unit has to purchase essential goods like computers, medicines, office supplies, vehicles and/or components and spare parts of vehicles, etc;

**WHEREAS**, moreover, an LGU has also to hire casuals to supplement limited workforce or enter into a contract of services with consultants /specialists, whose expertise in certain field of specialization are valuable and not available in the regular workforce of the LGU;

**WHEREAS**, the abovementioned transactions involves payments of public funds whose release requires approved and signed documents like vouchers, etc., thus;

**WHEREFORE**, on motion of Member Betsy Maria V. Zalsos, duly seconded by Members Samuel P. Huertas and Bernard Y. Pacaña

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, By the Sangguniang Panlungsod of Iligan, that the following City Ordinance be **ADOPTED** and **APPROVED**:

**CITY ORDINANCE NO. 22-7181**

**AN ORDINANCE AUTHORIZING CITY MAYOR FREDERICK W. SIAO, TO SIGN CHECKS, VOUCHERS, PAYROLLS AND OTHER FINANCIAL DOCUMENTS/NEGOTIABLE INSTRUMENTS, FOR ALL ACCOUNTS FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ILIGAN, AND TO FURNISH COPY OF THE SPECIMEN OF HIS SIGNATURE TO ALL DEPOSITORY BANKS WHERE THERE ARE DEPOSITS OF THE CITY GOVERNMENT, AS A MEANS OF DISBURSING THE CITY GOVERNMENT PUBLIC FUNDS**

Be it ordained by the Sangguniang Panlungsod of Iligan in its session assembled, that:

**SECTION 1.** –City Mayor Frederick W. Siao is **AUTHORIZED**, as he is hereby **AUTHORIZED** to sign checks, vouchers, payrolls and other financial documents, for all accounts for and in behalf of the City Government of Iligan.

**SECTION 2.** – City Mayor Frederick W. Siao is **AUTHORIZED**, as he is hereby **AUTHORIZED** to furnish copy of the specimen of his signature to all depository banks where there are deposits of the Iligan City Government, as a means of disbursing the city government public funds, which includes accomplishment of the required forms to realize the foregoing authority.

**SECTION 3. Effectivity** – This Ordinance shall take effect upon its approval.
