whereas, presented for consideration is the letter dated August 16, 2022 of City Mayor Frederick W. Siao endorsing the letter of the Executive Management Board Diyandi Festival Iligan 2022 requesting for the passage of an ordinance for the suspension of amusement tax on different activities and events, and payments for tarpaulins, streamers, and the like, for the duration of the festival;

WHEREAS, "All Systems Go" for this annual celebration of the 2022 Diyandi Festival, which highlights the Iligan Culture of unity, camaraderie, and love:

WHEREAS, the Executive Management Board has invited and sponsored certain activities and proponents to include different contests, agricultural, industrial and commercial trade fairs, carnival fairs and rides;

WHEREAS, there is a need to exempt from the payment of amusement tax some of the programs of activities whether fund raising or otherwise. Additionally, those stalls and stores located at Diyandi Fiesta Park at KCC Ground, Barangay Saray, Iligan City, shall be exempt from the payment of Amusement Tax and newly started business tax;

BE IT RESOLVED, AS IT HEREBY RESOLVED, By the Sangguniang Panlungsod of Iligan, that the following City Ordinance be ADOPTED AND APPROVED, as it is hereby **ADOPTED** and **APPROVED**:

CITY ORDINANCE NO. 22-7201

ORDINANCE SUSPENDING THE IMPLEMENTATION AMUSEMENT TAX ON DIFFERENT ACTIVITIES AND EVENTS, AND PAYMENTS OF TARPAULINS, STREAMERS AND THE LIKE AS STIPULATED UNDER SECTION 11 OF CITY ORDINANCE NO. 05-4807, FOR THE **DURATION OF THE 2022 DIYANDI FESTIVAL.**

Be it ordained by the Sangguniang Panlungsod in its session assembled, that:

SECTION 1. - There is **SUSPENDED**, as the same is hereby **SUSPENDED**, the implementation of amusement tax on different activities and entertainment events, concerts, parlor games and amusement stalls and carnival area and payments of tarpaulins, streamers, and the like as stipulated under Section 11 of City Ordinance No. 05-4807, for the duration of the 2022 Diyandi Festival.

SECTION 2. - This Ordinance shall take effect immediately.
