RESOLUTION NO. 22-550

WHEREAS, in today's session this body adopted Resolution No. 22-548, requesting City Mayor Frederick W. Siao, to resume/continue the operation of the "Night Market" due to the request of the stallholders of the night market and café and in order to raise the revenue of the city government;

WHEREAS, on September 16, 2011 this body adopted City Ordinance No. 11-5693, also known as "The Weekend Night Market and Café Ordinance of Iligan City", purposely to invigorate business among ambulant vendors after dusk;

WHEREAS, the passage of City Ordinance No. 11-5693 resulted to the temporary closure of some streets adjacent the Iligan City Freedom Park (Rizal Park) from vehicular traffic, during the duration of the Night Market which was from 5:00 P.M. to 3:00 A.M., during Fridays and Saturdays to accommodate the display of goods, merchandise, foodstuffs, commodities, or articles of commerce that may be sold and dispensed to the general public;

WHEREAS, the operation of the Night Market not only moved the revenue of the City Government northward, it also generated additional income to the stall holders, offered opportunities to new entrepreneurs and invigorate the business climate during night time. Moreover, it created an alternative night venue for local residents, family and their visitors and became a venue for host of activities like concert and food festival;

WHEREAS, due to various circumstances beyond the control of the City Government like the Marawi Siege which led to the imposition of Martial Law in Mindanao and the COVID 19 Pandemic which resulted to series of quarantines, purposely to protect the residents, and with no one soul brave enough to venture out of their homes in the dead of the night, lest he will be apprehended by the police and end up cleaning police stations, the Night Market clients trickled and eventually its operation stopped;

WHEREAS, now that the situation has somewhat stabilized, the stall holders of the Night Market clamored for the resumption of its operation to revitalize once more, the night economic activities of the City;

WHEREAS, considering that the roads and streets surrounding the Freedom Park are busy road arteries, there is a need to close it temporarily, in order to accommodate the vendors and consumers and to ensure their safety;

WHEREFORE, on motion of Member Simplicio N. Larrazabal, III, duly seconded by Member Betsy Maria PTV. Zalsos;

BE IT RESOLVED, AS IT HEREBY RESOLVED, By the Sangguniang Panlungsod of Iligan, that the following City Ordinance be, as it is hereby **ADOPTED** and **APPROVED**:

CITY ORDINANCE NO. 22-7202

AN ORDINANCE AUTHORIZING FOR THE TEMPORARY CLOSURE OF SOME STREETS ADJACENT THE ILIGAN CITY FREEDOM PARK (RIZAL PARK) NAMELY: PORTIONS OF DEL PILAR AND AGUINALDO STREETS FROM THEIR CORNERS AT MARIANO BADELLES SR., STREET TO BENITO LABAO STREET; MABINI STREET FROM ITS JUNCTION AT DEL PILAR STREET TO QUEZON AVENUE AND DEL PILAR STREET FROM ITS JUNCTION AT MARIANO BADELLES SR., STREET TO BENITO LABAO STREET, BARANGAY POBLACION, ILIGAN CITY, FROM 5:00 P.M.-12:00 MIDNIGHT, EVERY FRIDAY, SATURDAY AND SUNDAY, TO ACCOMMODATE THE VENDORS AND CUSTOMERS DUE TO THE RESUMPTION OF THE OPERATION OF THE "NIGHT MARKET"

Be it ordained by the Sangguniang Panlungsod in its session assembled, that:

Section 1. – Due to the resumption of the operation of the *Weekend Night Market and Café*, the following streets adjacent the Iligan City Freedom Park (*Rizal Park*) are hereby **TEMPORARILY CLOSED**, namely:

1. Portions of Del Pilar and Aguinaldo Streets from their corners at Mariano Badelles Sr., Street to Benito Labao Street;
2. Mabini Street from its junction at Del Pilar Street to Quezon Avenue
3. Del Pilar Street from its junction at Mariano Badelles Sr., Street to Benito Labao Street, Barangay Poblacion, Iligan City

Section 2. - Time and Day of Closure of Roads – During the duration of the Weekend Night Market and Café, the streets mentioned in Section 1 are temporarily closed from 5:00 P.M.-12:00 Midnight, every Friday, Saturday and Sunday.

SECTION 3. Repealing Clause. All previous ordinances, executive orders, rules and regulations or parts thereof which are inconsistent with this ordinance are hereby repealed and modified accordingly.

SECTION 4. Separability Clause. If, for any reason or reasons, any part or provision of this ordinance shall be held unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and in effect.

SECTION 5. Effectivity - This Ordinance shall take effect immediately.
