

RESOLUTION NO. 22-560

WHEREAS, in order to eliminate injuries caused by firecrackers during the celebration of the Yuletide Season, this body on November 3, 2016 passed City Ordinance No. 16-6523, entitled; "An Ordinance Prohibiting The Manufacture, Sale, Distribution, Possession Or Use Of Firecrackers Or Pyrotechnic Devices And The Exploding Of Firecrackers Or Other Similar Explosives Within The Territorial Jurisdiction Of Iligan City";

WHEREAS, in spite of prohibiting the manufacture, selling and using of firecrackers (Section 3) and imposing fines (Section 5) for the violators, there are instances however that the use of firecrackers are allowed (Section 4);

WHEREAS, Section 4 of said Ordinance states

"Section 4. Exemptions - The restrictions in this ordinance on the use or discharge of firecrackers do not apply if such use or discharge occurs due to the following:

- The use of pyrotechnic signaling devices or distress signals a. in emergency situations;
- b. A signal or ceremonial purpose in an athletic event; or
- The use of a pyrotechnic device by the police or military organization;

WHEREAS, Iligan City will observe and celebrate once again its annual fiesta this coming September 29, 2022;

WHEREAS, in order to prepare the activities in line with the 2022 Tourism Week and Fiesta Celebration, the City Mayor has reconstituted the Executive Management Board of the 2022 Diyandi Festival sa Iligan;

WHEREAS, the preparation for the 2022 fiesta is now on full throttle and to make it more memorable and lively, the Executive Management Board has programmed and calendared all coordinated activities for the duration of the Fiesta Celebration 2022;

WHEREAS, among the slated activities is the holding of fireworks shows during the opening salvo at Anahaw Amphitheater at 3:00 P.M. and at the Iligan City River Esplanade at 6:30 P.M. both on September 1, 2022;

WHEREAS, said activities are prohibited under Section 3 of City Ordinance No. 16-6523, unless the same is amended;

WHEREFORE, on motion of Member Michelle E. Sweet-Booc, duly seconded by Member Bernard Y. Pacaña

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Iligan, that the following Ordinance be **ADOPTED** and **APPROVED**:

CITY ORDINANCE NO. 22-7203

AN ORDINANCE AMENDING SECTION 4 (B) OF CITY ORDINANCE NO. 16-6523, "AN ORDINANCE PROHIBITING ENTITLED; MANUFACTURE, SALE, DISTRIBUTION, POSSESSION OR USE OF FIRECRACKERS OR PYROTECHNIC DEVICES AND THE EXPLODING OF FIRECRACKERS OR OTHER SIMILAR EXPLOSIVES WITHIN THE TERRITORIAL JURISDICTION OF ILIGAN CITY" BY ALLOWING THE FIREWORKS SHOW ANAHAW AMPHITHEATER AT 3:00 P.M. FOR THE OPENING SALVO AND THE DIYANDI FIREWORKS SHOW AT THE ILIGAN ESPLANADE AT 6:30 P.M., ON SEPTEMBER 1, 2022, AND ALL OTHER SALVOS THAT REQUIRE FIREWORKS, IN CELEBRATION OF THE 2022 DIYANDI FESTIVAL, INCLUDING OFFICIALLY RECOGNIZED ACTIVITIES OF THE LGU-ILIGAN, SUBJECT TO NATIONAL LAWS, AND RECOGNIZED SAFETY RULES AND PRECAUTIONS

Be it ordained by the Sangguniang Panlungsod in its session assembled that:

SECTION 1. Section 4 (b) of City Ordinance No. 16-6523, entitled; "An Ordinance Prohibiting The Manufacture, Sale, Distribution, Possession Or Use Of Firecrackers Or Pyrotechnic Devices And The Exploding Of Firecrackers Or Other Similar Explosives Within The Territorial Jurisdiction Of Iligan City" is **AMENDED** as the same is hereby **AMENDED** to read as follows:

"Section 4. Exemptions - The restrictions in this ordinance on the use or discharge of firecrackers do not apply if such use or discharge occurs due to the following:

b. A signal or ceremonial purpose in an athletic event; or "for the fireworks show at the Anahaw Amphitheater at 3:00 P.M. for the Opening Salvo and at the Iligan City Esplanade at 6:30 P.M., on September 1, 2022, and all other salvos that require fireworks, in celebration of the 2022 Diyandi Festival, including others officially recognized activities of the LGU-Iligan, subject to national laws, and recognized safety rules and precautions"

SECTION 2. The exemption as stipulated in the phrase "for the fireworks show at the Anahaw Amphitheater at 3:00 P.M. for the Opening Salvo and at the Iligan City Esplanade at 6:30 P.M., on September 1, 2022, and all other salvos that require fireworks, in celebration of the 2022 Diyandi Festival, including other officially recognized activities of the LGU-Iligan, subject to national laws, and recognized safety rules and precautions, shall expire at the end of 2022 Diyandi Festival Celebration.

SECTION 3. Repealing Clause. All previous ordinances, executive orders, rules and regulations or parts thereof which are inconsistent with this ordinance are hereby repealed and modified accordingly.

SECTION 4. Separability Clause. If, for any reason or reasons, any part or provision of this **ordinance** shall be held unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and in effect.

SECTION 5. EFFECTIVITY. - This Ordinance shall take effect upon its approval.
