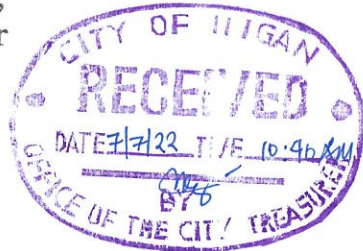

RESOLUTION NO. 22-392

RESOLUTION AUTHORIZING CITY MAYOR FREDERICK W. SIAO, TO WITHDRAW FROM THE FIDELITY BOND PREMIUM WITH ACCOUNT CODE 5-02-16-020, TO PAY FOR THE BOND OF CITY VICE MAYOR MARIANITO D. ALEMANIA, SUBJECT TO THE EXISTING, LAWS, RULES AND REGULATIONS

WHEREAS, to perform their mandated tasks effectively and efficiently, City Mayor Frederick W. Siao and City Vice Mayor Marianito D. Alemania have appointed key accountable officials whose functions involves the custody of funds;

WHEREAS, accountable officials/employees are the employees of the government whose duties requires the custody of funds or properties for which he is accountable and be deemed bonded and his fidelity insured in accordance with Section 314 of Public Bonding Law;

WHEREAS, Fidelity Bonding is an insurance of bondable public officers under the Fidelity Fund to assure they will faithfully perform all the duties imposed by law upon them and will faithfully account all funds and public property coming into their possession, custody or control;

WHEREAS, every officer, employee of the government performing duties which permit or require possession, custody, and control of public funds or public properties, including but not limited to provincial governors, city and municipal mayors, provincial, city, municipal and barangay treasurers, and punong barangays shall be bonded. Public officers designated as authorized signatories and counter signatories in the issuance of checks and approval of disbursement vouchers must also be bonded;

WHEREAS, the Iligan City Government has allocated amount for the Fidelity Bond Premium that can be utilized to pay the Fidelity Bonds of the current city's accountable officials, including the bond of City Vice Mayor Marianito D. Alemania;

WHEREFORE, on motion of Member Simplicio N. Larrazabal, III, duly seconded by Member Providencio A. Abragan, Jr.

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, By the Sangguniang Panlungsod of Iligan, to **AUTHORIZE**, as it hereby **AUTHORIZES**, City Mayor Frederick W. Siao, to withdraw from the Fidelity Bond Premium with Account Code 5-02-16-020, to pay for the bond of City Vice Mayor Marianito D. Alemania, subject to the existing, laws, rules and regulations.
